Dear Parents/Carers,

I would like to take this opportunity to let you know about the arrangements we have made for Year 11 for the rest of the examination period.

Starting on Tuesday 12th June students will no longer be expected to attend school full time. **They will however be expected to attend both their examinations and any revision sessions for subjects they are still to complete.** I have included details of the revision sessions for the remainder of this term below.

Details of all examinations will be available through the academy website. Please note that once the examination period has finished, some students could still be invited in to school to complete outstanding work for BTEC / NCFE courses. Failure to complete these courses may incur costs in the same way as failure to attend an examination does.

The Learning Resource Centre (LRC) will be available for students to revise in at all times during the examination period. This will allow students who would prefer to revise in school to have a quiet area with computer facilities available. If students do wish to take advantage of the LRC they must bring revision materials in with them so that they are able to use their time productively. Students who still want to use the school buses should use the LRC before or after exams so they have somewhere to work before getting their transport home. Late buses will leave at 4:10 pm Monday – Thursday and a village taxi will pick up at 4:15 pm Mon – Thursday but must be booked through Mrs Exley our school business manager.

We are still required to maintain accurate records of students on site for health & safety reasons. Consequently, students should attend registration as normal if possible. If they arrive in school after this time then they MUST sign in BEFORE going to any lessons. There will be a folder in the LRC for them to do this. If students leave the site, then they MUST sign out in the same place.
